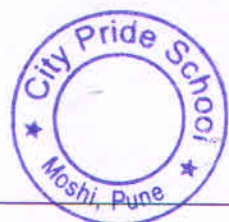

#### **Minutes of the Meeting:**

**Point no.1 : Welcome Note :** Principal, Mrs. Suja Rajesh welcomed all the EPTA members. Principal noted that the requisite quorum for the meeting was present and called the meeting to order.

**Point no. 2 : Confirmation of previous EPTA meeting :** Mrs. Shwetangna read out the minutes of previous EPTA meeting . The minutes were confirmed unanimously by the members by raising the hands.

**Point no. 3 : Half yearly Report:** Principal Suja Rajesh presented the half yearly report of the school till December 2019.



First of all Madam thanked all the parents for their timely support, feed back and suggestions given for a better academic and non-academic activities. The various events and activities conducted were are as mentioned below.

**Annual Day:** The Annual Gathering was conducted in the month of November [18-11-2019] in Ramkrishna More Sabhagruha, Chinchwad. Almost every student was a part of it. The enthusiasm, team spirit and support given by parents are commendable. The teachers had put in tremendous efforts in training the children for the same.

**Field visits:-** The field visits are completed for STD 1 and 2 as per the schedule. One visit is left for STD 3 and it will be done in the month of January 2020. After the field visits students were given activities based on the same.

The picnics too will be scheduled in the month of February 2020. The detailed notice regarding the same will be sent to the Parents.

**Intraschool Competitions:** The school has also planned intraschool competitions for our students. The students will be given consent regarding the event they wish to participate and it will be conducted in the month of January. The detailed notice was sent along with the consent on 2<sup>nd</sup> December 2019 and the last date given was 6<sup>th</sup> December. In case any parents missed it or forgot to send, they can send it as early as possible.

**Exams:** We have completed the Periodic Test 1 and the Half Yearly Exam. Now Periodic Test 2 will be conducted in the month of January and the Yearly Exam in March. As usual portion and time table for the same will be sent 2 weeks in advance to all parents.

**Competitions:-** Students have taken part in various competitions like shloka chanting, natyachhatta, music, dance, drama and also in sports events. They have won prizes too in those competitions.

**Point no. 4 : Admission Process for year 2020-21**

The principal informed the parents that the admission process for the next academic year 2020-21. She told that the admission process started in first week of December 2019 and is entirely online. There was overwhelming response for admissions like previous year. This shows the growing faith of parent in this area about City Pride School.

- Being a Konkani Linguistic School, Konkani Linguistic students will be given direct admission.
- Preference will be given to the siblings and teachers ward.
- The age criteria is as per current declaration of state government.
- No capitation fees are charged by school of any sort.
- Selection of eligible applicants is done by draw in front of parent representatives.

The list of selected students will be displayed in January first week. She also informed that for further details regarding admission, the parents can visit school website.

**Point 5 : Information about PTA fund :** Mrs. Manju Sharma informed the members that Rs.50/- has been collected as PTA fund from the parents for year 2019-20.

The principal informed the parents that the funds are being spent on the various heads of expenditure as decided by the members in the previous meeting. The funds are deposited separately for the same and separate accounts are being maintained.

**Point no.6 : Fees Fixation:**

Principal Mrs. Suja Rajesh informed the parents that though the fees structure for the school is Rs.71,500/- for the academic year 2020-21. Though the school has given concessional fees of Rs. 65,000/- to parents admitted in the year 2019-20 as school foundation year offer. Also as per the commitment given to these parents during admission in year 2019, the concessional fees will remain same in the year 2020 also even though the fees of all other students will Rs. 71,500/- for year 2020 .

She further stated that school management has agreed to keep the fees Rs. 71,500/- for the year academic year 2020, 2021 and also in year 2022 considering the fact that the trust is ready to support the school for beginning years hence the fees could remain same till year 2022.

Thus the EPTA members approved to continue the fee structure for the academic year 2021-22 as well as 2022-23 as follows. The fee rise will be for academic year 2023-24.



Tuition fees	Rs.61,286/-
Term fees	Rs.10,214/-
Total fees	Rs.71,500 /-

Thus The EPTA members unanimously decided that the fees for the Academic Year 2020-21, 2021-22 and 2022 -23 as above by raising their hand online.

Mrs. Suja Rajesh thanked the school management for the unconditional support given for this new school so that they can reach new heights.

**Point no.7 : Any other points**

Teacher representative, Mrs. Kiwi Soni stated that the teachers have a very safe and secure environment at CPS which is very crucial for their personal growth and the teachers are mentored and groomed in such a way that they are able to give their very best to the organisation.

Mrs. Rima Nagu informed the member that they are always available for school for any help in conducting any activities or functions in school.

Mrs. Memane Sugandha, the Education Dept. representative shared her views on the points discussed in the meeting and she summed it up saying that the school is functioning very satisfactorily. And she stated that the EPTA meeting was conducted in presence of principal, teachers & parents representative. The parents were satisfied with all the facilities for teaching learning of the school. The school conducts various activities and programs to develop the students. The fee structure was proposed by the management representative. It was unanimously accepted by the parent representative for the year 2019-20 & 2020-21.

**Point No. 8: Vote of Thanks :**

Mrs. Kiwi Soni proposed vote of thanks and announced that the next EPTA meeting will be in month of March. She informed the members that as the date is declared quite in advance, it is expected that all members may kindly make themselves available for the same.
